PORSCHE CLUB OF VICTORIA INC (PCV) PARTICIPANT OF THE YEAR AWARD 2012 *(Formerly Social Competition)* **SPONSORSHIP, PRIZES & RULES**

The Porsche Club of Victoria Inc (PCV) will conduct a new club award for the 2012 year. Previously known as the Social Competition, this new award will be available to all PCV members and is to encourage members' participation in a wide variety of PCV events. The PCV has therefore entered into sponsorship agreements with three companies to provide prizes for this competition which will be conducted during 2012.

Sponsors & Prizes

First Prize - Traction Tyre & Suspension Centre Award: Yokohama tyres of the winner's choice (subject to availability), from Traction Tyre & Suspension Centre, including fitting and balancing, to the value of **\$2,000** (prize to be claimed by 1 March 2014).

Second Prize – Porsche Cars Australia Award: Items of the winner's choice from the PCA Selection Department to the value of **\$400**.

Third Prize – Nillumbik Cellars Award: Wine of the winner's choice from Nillumbik Cellars to the value of **\$200**.

Participant of the Year Award

The competition will be open to all PCV primary members who are financial for the 2012 calendar year, but will exclude General Committee members holding office during the 2011 - 2012 Club Year, concluding at the AGM. Members with only family membership are not eligible.

Award of Points

Members who attend events conducted as part of the PCV 2012 Calendar will be awarded points with the following weightings.

- Four Points: Participation in the Annual Dinner Dance.
- Two Points: Participation at Social Events (identified as "SOCIAL" in the events Calendar on the website), and Register events with an overnight component.
- One Point: Participation in other Register Events.
- One Point: Participation in Competition Events, including as competitors, officials, marshals, and volunteers.

The weighting of points is to recognise the importance of the Dinner Dance, and the relative number of available events, (many Competition and Register, fewer Social).

Included Events

For 2012, eligible events are included from the 1st January 2012 to the date of the Annual Dinner Dance in 2012. In future years, eligible events are included from the end of the Annual Dinner Dance in the preceding year to the start of the Annual Dinner Dance in the current year. Only the current year's Dinner Dance is counted.

Awarding of Prizes

At the completion of the 2012 year (marked by the closure of acceptances for the 2012 Annual Dinner), the eligible member who has accrued the highest number of points for participation across all events (as indicated by PCV records) will be the winner of the First Prize, the eligible member who has accrued the second highest number of points for participation across all events will be the winner of the Second Prize and the eligible member who has accrued the third highest number of points for participation across all events will be the winner of the Third Prize.

Should a number of eligible members accrue equal highest points for participation across all events which results in ties for any of the prizes the prize winners will be selected randomly from the pool of the tied contenders by the President and Social Director. The first name selected will receive the first prize, the second name selected will receive the second prize and the third name selected will receive the third prize.

Announcement of Prizes

The prize winners will be announced at the 2012 Annual Dinner Dance (should a random selection from a pool of tied contenders be necessary, this will also be conducted at the Annual Dinner Dance). Vouchers for the prizes will be presented to the prize winners at the Annual Dinner Dance, or mailed to the prize winners if they are not in attendance. Winners' names will be published in Porsche Parade.

Guarantee & Disclaimer

In the unlikely event any sponsor withdraws their support or fails to honour a prize voucher, the obligation of the PCV is restricted to cash compensation equal to the stated value of the relevant prize. In accepting the prizes, the winners release and indemnify the PCV, its Committee and its members, from and against all actions, proceedings, claims and demands which may be brought by any person in respect of the use of the said prizes by the winners.

Disputes

Any dispute concerning the rules, conduct or results of the 2012 Participant of the Year Award, must be addressed in writing to The Committee of the Porsche Club of Victoria Inc. The Committee's decisions concerning such disputes will be final and binding on all members.
