PORSCHE CLUB OF VICTORIA INC (PCV) SOCIAL COMPETITION 2011 SPONSORSHIP, PRIZES & RULES

The Committee of the Porsche Club of Victoria Inc (PCV) has agreed to conduct another Social Competition for the benefit of PCV members and to encourage members' participation in PCV social events. The PCV has therefore entered into sponsorship agreements with three companies to provide prizes for this competition which will be conducted during 2011.

Social Sponsors & Prizes

First Prize - sponsored by Traction Tyre & Suspension Centre: Yokohama tyres of the winner's choice (subject to availability), from Traction Tyre & Suspension Centre, including fitting and balancing, to the value of **\$1,500** (prize to be claimed by 1 March 2013).

Second Prize – sponsored by Porsche Cars Australia (PCA): Items of the winner's choice from the PCA Selection Department to the value of **\$400**.

Third Prize – sponsored by Nillumbik Cellars: Wine of the winner's choice from Nillumbik Cellars to the value of **\$200**.

Social Competition Eligibility

The competition will be open to all PCV members who are financial for the 2011 calendar year, but will exclude Committee and Social Sub-Committee members holding office during the 2011 calendar year. A winner of a prize in the year prior is disqualified from winning the same place or lower in the following year

Social Competition

Members who attend nominated events conducted as part of the PCV 2011 Social Calendar will be awarded two points for each attendance at a 'Priced Event' (with four points awarded for attendance at the Annual Dinner Dance) and one point for each attendance at a 'Free Event' as follows:

'Priced Events' - Day Tours, Weekend Tours, Dinners, Show 'n' Shines (including any extended Tour and Annual Dinner Dance), or other social events nominated by the Committee, which require entry and payment. Members will automatically be allocated two points upon receipt of their official entry forms and payments (four points for the Annual Dinner Dance).

'Free Events' - Club Nights, Club BBQ's, the AGM or other social events nominated by the Committee, where no entry or payment is required. Members will have the option of registering their names, membership numbers and signatures in a 'Registration Book' to be made available at such events for this purpose, and will be allocated one point for each registration.

Excluded Events – All competition events and President's Day. Any BBQ, dinner or activity organised as an ancillary activity to a competition event (eg. Calder Sprints BBQ, Queen's Birthday Weekend Sprints/Motorkhana breakfasts, dinners and tours) or other such activity deemed by the Committee as 'not primarily a social event', are also excluded.

Awarding of Prizes

At the completion of the 2011 Social Calendar (marked by the closure of acceptances for the 2011 Annual Dinner), the eligible member who has accrued the highest number of points for attendances at 'Priced Events' (as indicated by PCV financial records) will be the winner of the First Prize, the eligible member who has accrued the second highest number of points for attendances at 'Priced Events' will be the winner of the Second Prize and the eligible member who has accrued the third highest number of points for attendances at 'Priced Events' will be the winner of the Third Prize.

Should a number of eligible members accrue equal highest points for attendances at 'Priced Events' which results in ties for any of the prizes, points those members may have accrued for their attendances at 'Free Events' (as recorded in the 'Registration Book') will then be added to their points totals to decide the prize winners.

If it is still not possible to determine the prize winners after taking into account accrued points from both 'Priced Events' and 'Free Events', the prize winners will be selected randomly from the pool of the tied contenders by the President and Social Director. The first name selected will receive the first prize, the second name selected will receive the second prize and the third name selected will receive the third prize.

Please Note: To ensure that prizes are distributed as widely as possible amongst members, the Committee has ruled as follows: "Where two members principally attend events together (eg. partners who attend events in the same car), they will be deemed to be 'one entity' under the rules of this competition. Should any two members so deemed accrue sufficient points to potentially claim a prize each, their entitlement shall be to one prize only, which will be the higher valued prize and awarded as a shared prize to both members".

Announcement of Prizes

The prize winners will be announced at the 2011 Annual Dinner Dance (should a random selection from a pool of tied contenders be necessary, this will also be conducted at the Annual Dinner Dance). Vouchers for the prizes will be presented to the prize winners at the Annual Dinner Dance, or mailed to the prize winners if they are not in attendance. Winners' names will be published in Porsche Parade.

Guarantee & Disclaimer

In the unlikely event any sponsor withdraws their support or fails to honour a prize voucher, the obligation of the PCV is restricted to cash compensation equal to the stated value of the relevant prize. In accepting the prizes, the winners release and indemnify the PCV, its Committee and its members, from and against all actions, proceedings, claims and demands which may be brought by any person in respect of the use of the said prizes by the winners.

Disputes

Any dispute concerning the rules, conduct or results of the 2011 Social Competition must be addressed in writing to The Committee of the Porsche Club of Victoria Inc. The Committee's decisions concerning such disputes will be final and binding on all members.
