The event will be run with **teams of 3 drivers**, where the combined fastest lap time of the drivers from each team will determine the winning team! **Individual entries** are welcome as we can allocate you to a team.

The on-track action will be made up of three groups of ten drivers and consist of the following:

- Each driver will compete in a **10 lap qualifying session** to determine the grid positions
- Each driver will compete in a **10 lap race heat** to sort out the men from the boys
- The bottom ranked drivers from the race heat will compete in a **10 lap Consolation Final**
- The top ranked drivers from the race heat will compete in a **10 lap Grand Final**

The fastest combined lap time of each team will be calculated and medallions will be awarded to 1st, 2nd & 3rd places on the night.




TERMS AND CONDITIONS OF ENTRY

Port Melbourne Go Karts Pty Ltd (trading as Auscart Racing, A.C.N. 130 596 468) whose registered office is situated at 4 /6 Atherton rd Oakleigh 3166, in the State of Victoria (hereinafter called "Port Melbourne Go Karts ") agrees to hire to the hirer whose name, address and signature appears below and to permit the Hirer to use its karts, services and facilities upon the terms and conditions hereinafter appearing.

The Hirer:

1. Agrees that the driving of go-karts is inherently dangerous and may lead to either death or injury. The Hirer voluntarily agrees to voluntarily accept all risks and danger prior to, during and subsequent to the driving of go-karts, including damage or injury caused by other drivers.
2. Agrees to use Port Melbourne Go Karts Pty Ltd services and facilities or occupy the premises and surrounds of 50 Salmon Street, Port Melbourne and any part of it at their own risk and release to the full extent permitted by law, Port Melbourne Go Karts Pty Ltd, and its staff, agent, invitees and licensees of Port Melbourne Go Karts Pty Ltd and each of them from all liabilities whatsoever arising (including but not limited to any negligence or breach of control) resulting from any accident, loss, damage or injury to the hirer or its his or her staff agents, sub-contractors, invitees, licensees or permittees.
-  3. Agrees to inform management to any pre-existing health conditions, including, any physical limitations or medical conditions, including but not limited to neck weakness, back weakness, recent surgery, broken bones, heart conditions, nervous disorders, motion sickness and epilepsy. Management recommends that pregnant women should not race.
4. The hirer by this agreement indemnifies Port Melbourne Go Karts Pty Ltd and agrees to keep Port Melbourne Go Karts Pty Ltd always indemnified in respect of all loss, damage, consequent loss and damage claimed by any person against Port Melbourne Go Karts and legal fees or consultants fees which Port Melbourne Go Karts may suffer or incur and all money which Port Melbourne Go Karts may become liable to pay any person in respect of or arising directly or indirectly out of any act, default or omission on the part of the Hirer or its his or her employees, servant, agents, invitees, licensees and/or permittees.
5. Agrees to abide by the rules and regulations established by Port Melbourne Go Karts Pty Ltd from time regarding the use and facilities and services of Port Melbourne Go Karts and shall comply with all lawful directions of Port Melbourne Go Karts as are given from time to time.
6. Grants permission to Port Melbourne Go Karts and their agents to utilise the Hirers image or likeness incidental to any photographic record live or recorded video displayer or any other transmission or reproduction in whole or in part, in any way which Port Melbourne Go Karts or such authorised person sees fit.
7. Agrees that Port Melbourne Go Karts may for any reason whatsoever terminate this agreement and require the hirer to leave the premises. The Hirer agrees to abide by the directions of Port Melbourne Go Karts and leave the premises when directed to do so.
8. The expression "the Hirer" shall mean the Hirer or that referred to herein and his legal personal representative. The Hirer acknowledges that the terms and conditions hereof have been made available to the Hirer and that the Hirer has read and understood the same prior to entering into this agreement and acknowledges such by signing hereunder.
-  9. The hirer will accept responsibility and pay for all deliberate damage caused to Karts and Equipment used by the Hirer at cost.
10. Port Melbourne Go Karts Pty Ltd Refuses the right of entry any patron on the grounds of intoxication. Port Melbourne Go Karts Pty Ltd Policy on Liquor is 0.05 Blood Alcohol level before racing . Any Participants who do not obey these regulations will not be allowed to race.
