Drivers are required to have their own helmet that is CAMS compliant Level A Australian Standard 1698. Non-flammable clothing that fully covers flesh from ankles up to and including neck and wrists is required at a minimum however racing suits are recommended. Fully enclosed flat soled leather shoes are mandatory.

#### Vehicle entry

All participating Porsches must be road registered in a state or territory of Australia and compliant under all applicable laws and/or regulations. Competition vehicles are not permitted nor is the use of 'slick' tyres. Signage and/or graphics other than standard Porsche branding which appears on vehicles sold to the general public is not permitted on any vehicle. All vehicles must be mechanically sound, roadworthy and free from any fluid leaks. PCA suggests having your car checked over by an Official Porsche Centre prior to the event. Scrutineering on the day will be completed by CAMS. All participating vehicles must be made available for a basic safety check by CAMS personnel prior to commencing on track activity. No major alterations are required to your car such as fire extinguishers, racing harness-es, roll cages, bonnet clips etc. No technical support, spare parts or fuel will be available within the Albert Park circuit. Therefore it is mandatory that you commence the day with a full tank of fuel and road worthy set of tyres.
