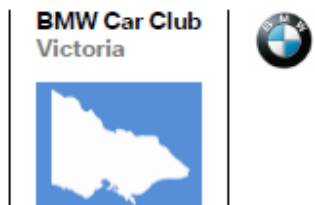


**BMW Car Club of Victoria**
